In continuation of our letter Ref. No. MWL/CS/NSE/2022-23/17 dated 29<sup>th</sup> September, 2022 and other communications and pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform you that pursuant to Hon'ble NCLT Order dtd 26<sup>th</sup> July, 2022, Resolution Plan and Scheme Amalgamation, the Company has made entire payment upto Rs. 6.35 Crore and the last payment was made on 28<sup>th</sup> September, 2022. Hence, the Scheme of Amalgamation has become effective from 28<sup>th</sup> September, 2022 and Vicor Stainless Private Limited ('VSPL') has been merged/amalgamated with Mangalam Saarloh Private Limited ('MSPL'), a subsidiary of Mangalam Worldwide Limited (MWL) with effect from 26<sup>th</sup> July, 2022 and the Registrar of Companies, Gujarat has approved the filing of Form INC-28 and given the effect of said merger/amalgamation.
